We could look upon this last year of mask wearing and social distancing as continuation of last year's Lenten experience. You will certainly recall we were in Lent as the crisis began.

Refresh yourself in the knowledge we will be coming to an end of our year long penance with the dawn at Easter. While it is somewhat likely we will still experience masks on April 4th—Jesus' Resurrection overcomes our year long Lenten experience of isolation and cancelled events. It is certainly the case then that this year's journey will be a great refreshment compared with this past year.



members of the St Patrick's parish and active in church & many, many church organizations. Jim's working career involved working for the Juneau County Highway Shop & the United States Postal Service. Jeri was the long time Juneau County Register of Deeds.

Undoubtedly, one of Jim's biggest accomplishments is having served as the KC's longest serving board member, acting as treasurer for 60 years! We have always been thankful for Jim's guidance, financial thriftiness and wonderful attention to detail for the council's business matters. There are many other activities throughout church but highlighted by friends at St Pats is his faithful working of the dishwasher during funeral dinners and his fall festival ticket sales.

Jeri is known throughout the parish for her tireless hours of volunteering for the church. When she retired from Juneau County, you were more apt to find her at the rectory than at home. New Supreme Knight—Patrick E. Kelly

Beginning March 1, 2021 after some 20 plus years, the Knights of Columbus will have a new Supreme Knight, Patrick Kelly. Carl Anderson has reached the mandatory retirement age for the role of Supreme Knight. The Board of Directors elected Deputy Supreme Knight Patrick Kelly to take over the reigns of the Knights of Columbus.

The Knights of Columbus Board of Directors elected Patrick E. Kelly as the 14th Supreme Knight on Feb. 5, to continue the mission of charity, unity and fraternity established by the Order's Founder, Blessed Michael McGivney, almost 140 years ago.



Mr. Kelly's election as Supreme Knight follows a distinguished career in the Knights of Columbus, the military and public service. For more than 25 years, he has a demonstrated track record of service to Church and country, which will serve him well in advancing the Knights' mission of Charity, Unity, Fraternity, and Patriotism.

Mr. Kelly has served as Deputy Supreme Knight since 2017. Prior to that, he served as Vice President for Public Policy for 11 years, spearheading the Knights' interaction with the White House, Congress and federal agencies. He has also served as State Deputy in the District of Columbia. As a longtime executive and fraternal leader of the Knights of Columbus, he has consistently strengthened its record of charity, advocacy, insurance, investment and membership growth.

Mr. Kelly served as the first executive director of the Saint John Paul II National Shrine in Washington, D.C., and oversaw the renewal of the facility after its purchase by the Knights in 2011. During his tenure, the shrine became a leading pilgrimage site and a source of education and inspiration for Catholics throughout the United States and the world.

Prior to his leadership roles in the Knights, Mr. Kelly pursued a lengthy career of public service. Most notably, he was Senior Advisor to the Ambassador-at-Large for International Religious Freedom at the State Department from 2005 to 2006. His responsibilities included serving as the Department's principal liaison with the Holy See and assisting with the formulation of U.S. foreign policy on religious freedom worldwide. He led U.S. delegations to the World Summit on Islamic-Christian dialogue (2005), the UN conference on interfaith cooperation (2005), and annual Sant'Egidio conferences. He has also held advisory roles on the House Intelligence Committee and the Department of Justice, where he specialized in counterterrorism and national security.

Mr. Kelly served in the United States Navy for 24 years, on land and sea and on active duty and reserve status. As a Judge Advocate General, he specialized in international and operational law and served as the Commanding Officer of the international law unit at the U.S. Naval War College. He served on the staff of the Deputy Chief of Naval Operations and aboard the USS Guam as the Staff Judge Advocate for Amphibious Squadron Two. His personal awards include three Navy Achievement Medals, five Navy Commendation Medals and the Meritorious Service Medal. He retired from the JAG Corps Reserve in 2016.

Mr. Kelly has served as consultant to three committees of the U.S. Conference of Catholic Bishops (USCCB) for more than a decade: The Committee on Pro-life Activities, the Committee on Religious Liberty, and the Subcommittee for the Promotion and Defense of Marriage. Mr. Kelly has been the Chairman of the Board of Directors of the March for Life since 2012. Under his leadership, the March for Life has become one of the most effective pro-life organizations in the world. He has also been a member of the Board of Directors of the National Catholic Bioethics Center (NCBC) since 2013. He has helped guide the NCBC in its mission to promote respect for the dignity of each human being through an understanding of how the moral teachings of the Church apply in health care and the life sciences.

Mr. Kelly holds a master's degree in theology from the Pontifical John Paul II Institute for Studies on Marriage and Family at The Catholic

University of America, a law degree from Marquette University Law School and a bachelor's degree in economics from Marquette University, where he joined the Knights of Columbus in 1983.

He and his wife, Vanessa, have three daughters.

As we close an incredible evolution of the Knights in the past 20 years under the leadership of Carl Anderson, the Knights are well positioned to continue its strength of membership and leadership to build up the body of the Church which is Christ risen.

Compass Minutes—January Meeting

Meeting began at 7pm. After opening prayer and pledge the minutes of the December 15, 2020 meeting were approved as written and earlier in the day communicated by email to the membership. Chaplain's report: Fr. John read from the "Knights to Christ" reading on Patriotism dealing with having reverence for all life. In the story was this quote from Hubert Humphrey: "The moral test of government is how it treats those who are in the dawn of life, the



children...in the twilight of life, the aged...in the shadows of life, the sick the needy, and the handicapped."

Fr. John told us about upcoming events: Every Friday Adoration with Benediction 3-4pm in the church except first Fridays (next date is Feb 5th) when adoration is from noon to 6pm. The Knights are responsible for a presence from 4-5pm. January 23/24 weekend Masses we have a priest from Cross Catholic International who will be the celebrant and talk to us about the organization he represents. Ash Wednesday is February 17th.

Fr. John took some time to visit and Supreme web site and was impressed with numerous videos the Knights have produced. He encouraged all members to visit the site – www.kofc.org – and explore the videos especially the one on the home page that reviews what the Knights have done in 2020.

Grand Knight report: The State Deputy sent an email announcing that the State Convention May 1-2, will be offered both in person and virtual. Delegates and attendees can decide which they prefer to do. Steve was not able to get a January newsletter sent. The February issue will go out to members before February 12th. In the weekend bulletin February 13th/14th will be the first two pages of the newsletter.

We have a new Honorary Life recognition, Dale Pellegrini. We will look for an opportunity to present him his lifetime honorary life card. We will do a profile article on Dale in a future newsletter.

There was no Treasurer report.

For membership, Supreme has again extended the free online membership, now to the end of the fraternal year, June 30, 2021. If our council recruits one new member from January 1 – March 15th, the council will not have to pay April-September state per capita. That one new member means a savings to the council of roughly \$230 (55 dues paying members x \$4.25). We do have one online member who still needs to take his exemplification to be transferred to our council and that would count for the one new member.

There are some Supreme deadlines coming as follows (must be done as part of Star Council qualification):

January 31st – Annual Fraternal Survey – every member should have gotten a dues statement that contained this survey which we asked be returned with dues payment.

January 31st – Special Olympics Partnershp Profile [has been submitted] February 15th – Semi-Annual Audit

Family of the Month for December is Jim and Jeri Kolba. The submission to Supreme and State was passed around the room for all to review. Our Family of the Year must be selected and submitted by February 15th. The Family of the Year must be a Knight and does not necessarily have to be one of our monthly selections. If you have someone you would like to nominate, contact our Family Director Jon Field.

Our council Free Throw contest will be Sunday January 31st in the school gym. Registration is from 11-noon, with the contests starting at noon. If you can help, we need volunteers to arrive before 11:30am so

instructions can be given on how to help. Randy Boehm is chairing the event. If you can help contact him at 847-4588. Best time is Monday thru Thursday 6:45-8pm.

January 23/24 Masses will be the "no-bake" pancake breakfast benefiting the 6th grade. Volunteers were requested. Howard Boppart and Steve Powers are covering the 10am Mass, Steve Hesprich and Randy Boehm will cover the 8am Mass. Steve Hesprich and perhaps Dick Schwab will cover the 5pm Mass. If you can help after the Mass you are attending, just come to the gathering area after Communion.

The 5th grade "no-bake" will take place February 20-21 after the Masses.

Steve Powell reported on the sales of the State Raffle. He's collected roughly \$1500 to this point. It is a bit behind last year. Toward Star Council

In the moments before we conducted
elections in July for Grand Knight, I made it
very clear that if members voted for me,
they should know that Star Council was to
be a goal. I am grateful all present on July
18th voted for me to become the Grand
Knight. We have a wonderful group of men
and families and it has been satisfying to
develop friendships and serve others.

Only about 15% of councils achieve this goal. In the time of Covid, Supreme has lightened the requirements, knowing that councils are more constrained in activities. The reason for Star Council recognition, is not simply for recognition. Over the



decades Star Council has been awarded, it is more of a testament that a council is performing those activities that are the hallmark of the Knights—that being the charity, unity & fraternity upon which the vision of Fr. McGivney was built.

Now that we are just past the halfway mark of the fraternal year, it is time to take stock of our status toward that goal. Let's begin by first describing the components of Star Council. The details we'll cover only apply this fraternal year because of Covid.

The Star Council Award recognizes outstanding achievement in membership, insurance and programming. In order to achieve the Star Council Award, a council must earn 1) the Father McGivney, 2) Founder's, and 3) Columbian Awards. Additionally, 4) the council must submit both the Annual Survey of Fraternal Activity (#1728) and Service Program Personnel Report (#365). 5) A council must be fully compliant with applicable safe environment requirements.

Let's break this down as to what we've completed and what remains to be done on or before June 30, 2021.

1) Fr. McGivney Award (25% of goal)

The Father McGivney award recognizes excellence in a council's membership growth. Our council must meet or exceed our membership

quota of 4 net members using council's membership as of July 1, 2020.

We have an interesting issue in play right now because the

One new member by March 15th for our council means the council will save \$230+ in State per capita; that is \$230 that could be used for a charitable cause.

State has an incentive for councils who get a designated number of new members (different for each council based on member size) between January 1st and March 15th. They will not have to pay state per capita for the April through September period. Our quota is one NET new member. If we achieve that, the council will not have to pay approximately \$230 in per capita for the State. It doesn't take a rocket scientist to understand this \$230 could be used by our council to support a charity of our choosing.

We have a net of one new member so far this fraternal year, but that was in July 2020. Including the one we need to join by March 15th, we have three new members still needed to achieve the Fr. McGivney Award.

2) Founder's Award (50%)

This award recognizes excellence in a council's promotion of our top-rated insurance products. To win this award our council must host two approved Fraternal Benefit Seminars, in conjunction with our Field Agent, Greg Helgerson.

To date we have hosted one Fraternal Benefit event. For the second one we are looking to see if a retirement seminar we promoted heavily in October might count. However there is an excellent Estate Planning seminar coming our way virtually (see article on page 4) that may allow us to qualify if the October one does not. Even if it does, this is an excellent seminar to attend.

3) Columbian Award (50%)

This award recognizes excellence in a council's programming and charitable outreach. To earn this award our council must conduct and report programs in each of the four program categories (Faith, Family, Community, and Life) for a total of 16 program credits, with four in each category. Here's what I see as accomplished to date:

- A) Faith—Memorial Mass Nov 2, 2021 along with 4-5 times per year a Mass intention; Council weekly Adoration. We need two other activities.
- B) Community—Fall Festival root beer floats; No-bake breakfasts; Leave no neighbor behind (support of local food pantry and food boxes); Hunter's Raffle (in progress). We have met the requirement of 4 activities.
- C) Family—Recognizing a family of the month for all 12 months (we've done 7 so far), will earn us 2 activities; We just completed the Free Throw Contest, leaving one more activity.
