


Christ's Compass— All Things New


Dawning of a new (K)night—Fr. Jey Yobu

One of my great pleasures as the membership director of the council is to get to know a man who quickly sees the value of the mission of the Knights of Columbus. Fr. Jeyaseelan "Fr. Jey" Yobu has been in the United States for a little under 3 years. He came to the United States from Southern India. When he arrived in Wisconsin and the Diocese of La Crosse, he was assigned to two small rural churches, St. Ansgar in Blair and St. Bridget in Ettrick where he served for two years.

Fr. Jey was Ordained a priest in 2004 for the Archdiocese of Madurai, India. After his Ordination he was appointed as the personal secretary and Master of Ceremonies (MC) for the Archbishop of Madurai. He then served for 10 years for the diocesan Social Service Centre, eventually becoming its director. In this role he travelled throughout the archdiocese to do the works of upliftment and empowerment of the socially and economically disadvantaged people. He was then assigned, interestingly, as Pastor of St.

Patrick parish in India in 2015, where he served for nearly 5 years, a large parish of over 1100 families.




On Tuesday, December 19, 2023 we had a welcoming/induction ceremony in which

Fr. Jey became a member of the Knights of Columbus. You can see in the photo above Grand Knight Steve congratulating Fr. Jey after a 3rd degree Knighting with the fourth degree sword.

Each year our State Raffle provides charitable monies in the form of rebates to councils for their charitable programs. The State also retains some

of the raffle proceeds for statewide needs. This Fall our council tapped into the State raffle monies to help Fr. Jey who had two difficult circumstances in September that had financial impact on his life. An automobile accident early that month, and then the death of his oldest brother in India, took him unexpectedly home for that brother's funeral. Our council submitted a state

Along with activities our council conducted in the parish he could easily see the contributions of the Knights, and the value of becoming a member. We look forward to serving Fr. Jey as Pastor of St. Patrick and now a member of the Knights of Columbus.






Council Compass— Remember Charity

Warm the Children


This fall our council embarked upon an involvement of a program, now several years in the making, called "Coats for Kids". To date over one million coats for children and teens have been distributed by councils throughout North America. One of the improvements made in this program was to distribute much warmer coats than in the past, so as to meet the harsh winter cold in Wisconsin. Our council started this program modestly, ordering a case (12 coats) for boys, and one for girls, 7-12 year olds. We had a 3-part plan for the give-away of these coats, with each part dependent on having remaining coats from the earlier giveaways. First, we offered coats to the children at St. Patrick's grade school and then the parish. We saw 7 boys, and 3 girls coats given. Second, we took the remaining coats (5 boys and 9 girls) to St. Mary's in Lyndon Station and offered them to parishioners in need, as well as for their Wednesday night student Catholic formation classes. We saw 2 boys and 2 girls coats given. Finally, the third step was to go to West Side Elementary who has a clothing closet (which our council supported financially a couple of years ago), to whom we have given the remaining 3 boys and 7 girls coats.

Compass of Leadership in the Knights

Knights are generally aware of the hierarchical structure

of the Knights. A council is part of a district which consists of four councils in the case of our District 20. There is a Diocesan, then State set of leaders. Among each of the State officers, one is assigned to give particular assistance to a diocese.

Dawning of a new (K)night—Patrick "Mick" McCormick



We also had a brief discussion about the possibility of forming a council. We would probably need about 25 members to make it possible. We have about half that number at the moment.

Tootsie Rolls—CPID

Our Knights of Columbus council presented checks from this past May's Campaign for People with Intellectual Disabilities, commonly known as the Tootsie Roll Drive. Jon Field chaired this year's campaign as we again raised a substantial donation total. The monies received are sent to the State Council, from which the State deducts the cost of Tootsie Rolls, and 10% for State CPID Charity use. When we send the monies, we designate a percentage to go to one or more causes. The State then sends the check to our council for distribution to the beneficiary organizations. Our council voted to have 90% of proceeds donated to the Mauston School District's special needs program, and 10% to St. Patrick School.

50 Golden Years of Knights in Wisconsin

Preface: The Wisconsin State Council published a book in 1952 entitled "50 Golden Years Knights of Columbus 1902-1952". This is the second of several excerpts that will be published in this and upcoming newsletters.

[This month we continue the commentary on this publication by introducing the charter council officers, say a bit about the charter members, and continue the history after the formation of the council.]

A few nights after the institution of the new council, the members met in the council club rooms in the school basement and elected the following officers:

Joseph Zobal *Rev. George Schleicher One year later an anniversary class of forty-two candidates was initiated in the same school hall, and since that date there have been additional members each year, until the membership as of August, 1951 was 181.

The council went into real Catholic Action soon after its organization. One of its early projects was the raising and appropriation of \$90.00 [\$1,041] in 2023 dollars] to Rev. Father Schwartz for the purchase of athletic equipment for the boys of St. Patrick's school.

Each Holy Thursday, Since 1937, the council has held an all-night vigil. An amusing incident occurred at the first vigil. Each pair of knights was

to be relieved at the end of a half hour. Brothers Jerry Carrigg, now deceased, and John F. Arkulary were next to the last, and were to be relieved at 7:30 on Good Friday morning. Came 7:30 and no relief showed up, so Brother John crossed the aisle and told Brother Terry that he must go to the store to open and turn on the heat. Brother Jerry remained a short time and still no replacements, so he devoutly went to the altar and blew out all of the vigil lights before leaving.

This council held good-will luncheons with Masons, American Legions, and others occasionally. They have successfully sponsored a Good Friday closing program in Mauston. They have always sponsored the parochial school essay contest, and in 1941 they had the distinction of having Miss Mary Helen Schroeder of St. Patrick's parochial school as the winner of the all statewide essay contests. This council has given ten dollars annually to the Catholic Hour. In 1948, one hundred dollars was donated to the diocesan seminary and thirty-five dollars to the Catholic Charities of the diocese. The members turn out almost solidly each Easter for corporate Holy Communion. They have always donated liberally to the Red Cross, Infantile Paralysis, and other programs, as well as such causes as Father Flanagan's Boys Home, the Diocesan Orphanage and Big Brothers program in the La Crosse diocese. The Council sponsored Days of Recollection in 1949 at New Lisbon and in 1951 at Mauston. They also conducted a Holy Year pilgrimage starting at Mauston, New Lisbon, Camp Douglas, with the final visit at Mauston in 1951.

Next Month we continue the story of our council's first 15 years by talking about the 4th degree and involvements during the WWII.

Compass Minutes—November 2023

The November 21, 2023 council meeting began at 7:02 pm. After an opening prayer and Pledge of Allegiance, the council conducted a new member exemplification of the principles of Charity, Unity and Fraternity. We welcomed Patrick "Mick" McCormick as a new member of the Knights.



[see profile on page 4] After the exemplification we started the business meeting. Minutes of the October 17, 2023 meeting were approved as published in the Nov/Dec 2023 newsletter. Fr. Cryton

thanked those who helped with the Pancake Breakfast at St. Mary's in October. He mentioned attending the 4th degree Clergy Appreciation Dinner in Tomah on Sunday November 19th. We then presented Fr. Cryton with his Honorary Life membership card which all priests who become Knights, receive. There is a joint Madison/La Crosse Diocese KC meeting on Sunday December 3, 2023 at Chula Vista in Wisconsin Dells. Grand knights, deputy grand knights, financial secretaries, program and membership directors are invited. Bishop Donald J. Hying of the Madison Diocese will be the featured speaking, talking about the Eucharist.

Treasurer's report: General Account had an opening balance of \$2,388.43. Two deposits were made of \$596 for the St. Mary Breakfast in October (money to be segregated for St. Mary Knights use) and St. Patrick November Breakfast proceeds of \$735. A check for \$45.41 for Pass Punt and Kick contest medals was written to Jon Field and one for \$29.52 was written for the St. Mary Breakfast expenses to Howard Boppart (reduces the segregated amount for St. Mary Knights use). The ending balance was \$3,644.50. After segregating St. Mary Knights monies, the general account balance is \$3,078.02. Charitable Fund at BMO bank had a beginning balance of \$1,006.85. \$320 was added for the St. Patrick Fall Festival for an ending balance of \$1,326.85. Howard Boppart mentioned we get supplies that are used across multiple breakfasts, but the way it's happened in the past, one of the breakfasts gets that cost. Instead we should allocate costs across all the breakfasts and provide a more equitable distribution of net proceeds to each breakfast beneficiary (especially the ones for the 5th through 8th grades).

Membership: State has a new incentive to give a \$100 Spring per capita credit if 5 new members come in between Nov 1 and Christmas 2023. We read the recent bulletin letter from Fr. Jey regarding his support of the That Man Is You (TMIY.org) program. A motion was approved for \$50 to pay for five Masses for the intention of living and deceased Knights over the next year. The first 4 of those will be 5th Sundays. The fifth one will be for the annual Memorial Mass for deceased Knights of our council. That will be Sunday November 3, 2024 at the 8 am Mass. We expect again to have an honor guard for that Mass.

Community Director: Breakfast with Santa to be promoted with the December 10th Pancake Breakfast. Signs and magnets for "Keep Christ in Christmas" had just arrived and were shown to the council. We will sell those for \$5 each both at St. Pat's and St. Mary's. Reminder to promote the State Raffle tickets to businesses, to have them help sell them. We have received the CPID checks for Mauston High School special needs (90%) and St. Pat School (10%). The calendar of events was reviewed. February's council meeting will be at St. Mary's. March 10th will be the St. Mary's Pancake Breakfast.

Financial Secretary: We received the CPID checks which will be presented to the Schools who are the beneficiaries. \$25.73 will be reimbursed to GK for new member kits purchased. Liability Insurance will be paid for \$315. A motion was made and passed for \$500 donation to the Food Pantry through Bank of Mauston which will match our donation.

A motion was passed to buy 18 youth bibles for \$12.50 each (total \$225) - We won't buy them right now but in time to be presented in May 2024.

We closed with petitions for Brian Fox's sister Connie, for Fr. Jey's return to health, for the repose of the soul of Mary Ann Strack, and for surgery recovery of Pat Michelle. The meeting ended at 8:45 pm.

Compass of Tax Protection—Life Insurance

In the last issue of 4th Watch of the (K)night we introduced the idea of a new program called "God Country Flag". This phrase, one nation under God, is the motto introduced in our country's Pledge of Allegiance. The Knights of Columbus had a material influence in adding the words "under God" to the Pledge in the 1950s. One of the



greatest tributes to the Pledge of Allegiance was performed by a well known comedian of the 1950s and 60s, Red Skeleton. In a video easily found in a

search of the Internet, one can find his infamous breakdown, word by word, of the Pledge. Today we take for granted these added words "under God". As Red Skeleton is first explaining "one" and "nation" in his tribute to the pledge, he initially doesn't mention the words "under God". It becomes more poignant when he purposely comes back to talk about the addition of "under God".

It is the intent of "God Country Flag" to be a presentation program involving emotional sentiments of loyalty represented by the flag to God and Country, to emphasize the importance of the Pledge of Allegiance, always recited in the presence of the flag, to appreciate the history of our flag, especially in Wisconsin. We need all Americans, born here or immigrants who make America their home, to understand the sacrifice of life that has made our flag so important. Finally we need to know the underlying reasons for the design of the flag which points to important principles of our nation's founding.

124 Years

125th anniversary of the 4th degree is Feb 22, 2025

On February 22, 2024, the 4th degree will be 124 years old.

We are roughly one year away from the 125th anniversary of the 4th degree of the Knights of Columbus' Patriotic degree. The most influential Knight in all the early formation of the 4th degree was John H. Reddin. I was fortunate to have many involvements with the first Knights of Columbus council established west of the Mississippi River, Council 539 in

Denver Colorado through my involvements with that council inn the early 2000s. The council was established in 1900 through the initiative of John H. Reddin who was its first Grand Knight for 3 years. His involvement in the fourth degree is nothing but impressive. It begins however as a 3rd degree member....

Not satisfied to be the "Mother Council of the West," Reddin and his Degree Team headed by J.K. Mullen chartered a private train in 1901 and traveled west from Denver to Leadville to Salt Lake City, Los Angeles and San Francisco and up the coast to Seattle and Tacoma, Washington, and back down the Pacific Coast as far south as Mexico City, and then back to Denver, through New Mexico and Arizona, founding councils all along the route. This Degree Team became

known as the foremost Ceremonial Team in the country. In 1903, Reddin became the founder with others, of and composed the Ritual for, the Fourth Degree of the Knights of Columbus, the patriotic degree of the Knights. He was the first Supreme Master of the Fourth Degree until his death on December 30, 1940 at the age of 82. He was on the Board of Directors of the Supreme Council for 33 years until his health forced him to step down.

At the inception of the 4th degree it was necessary to make an arbitrary selection of the candidates. Roughly 1400 members where so chosen for the first grand exemplification which was held in New York on February 22, 1900*.

There is much to be said about the value of the Patriotic Degree. Here we have presented the beginnings of its 124 year history.

Just four days earlier an honor guard of 21 accompanied his Eminence, Cardinal Burke on the occasion of the Feast of Our Lady of Guadalupe. When the Cardinal came to the narthex at the Shrine church, he commented about having 21 men just a few days earlier,

noting only 3 were there today. Color Corp Commander Frank DiBenedetto replied, "today you have the three best honor guard members".

... the Virgin Mother of God, Our Lady of Guadalupe, announced to Saint Juan Diego at the very beginning of her apparitions to him from December 9th to 12th of 1531:

Know, know for sure my dearest and youngest son, that I am truly the ever perfect Holy Virgin Mary, who has the honor to be the Mother of the one true God for whom we live, the Creator of people, the Lord of all around us and of what is close to us, the Lord of Heaven, the Lord of Earth. From the symbols imprinted upon her most beautiful garment, Saint Juan Diego knew that she was with child and from her words he understood that

the Child was God the Son Incarnate in her womb.

Carl Anderson, the then-Supreme Knight of the Knights of Columbus, and Monsignor Eduardo Chávez, renowned scholar of the Virgin of Guadalupe, in their book, Our Lady of Guadalupe: Mother of the Civilization of Love, help us to understand the power of the symbols and of Our Lady's words. Commenting on how Our Lady used titles for the Supreme Being from the ancient pagan culture – for whom God was inaccessible and therefore unknown – to refer to her Divine Son, they explain for us how the wonderful mystery of her Divine Maternity is symbolized in her most beautiful garment: In the apparition account, Our Lady of Guadalupe speaks of her Son using these titles (Him for whom one lives, Creator of people, Owner of the near and close, Lord of heaven and earth). And yet, it is absolutely clear that she is speaking of Christ. ,,,

The cause of our joy today, the cause of our abiding joy, the cause of our eternal joy, is Christ, God-the-Son Incarnate, Whom His Virgin Mother brought into the world and to Whom she is ever drawing us, showing us that He, seated at the right hand of God-the-Father in glory, is also with us in His holy Church which, together with the Virgin Mary, we rightly call Mother.

Christ is the fulfillment of man's deepest desire: to know God and to love and serve Him. Our Lady uses the ancient pagan language to show that



Christ alone fulfills man's deepest longing. She does not reduce her Divine Maternity to the understanding of the pagans but manifests the truth that the Redemptive Incarnation corrects, elevates, and perfects that understanding. Christ's Coming into the World is, as His Public Ministry shows, always the invitation to conversion of life. The first words of Our Lord's preaching are:

"The time is fulfilled, and the kingdom of God is at hand; repent, and believe in the gospel." In fact, we know that, subsequent to her apparitions, in a relatively short space of time, millions of pagans received the grace of Faith and Baptism....

The Church in our time faces similar seemingly impossible challenges. Human life itself, marriage and the family, and the practice of the faith are all under constant attack from a culture which refuses to recognize God and to submit in obedience to His commandments. Many today violently rebel against God Who reveals

Himself to us through reason and, most fully and perfectly, through the Catholic faith. The rebellion has beguiled even members of Christ's Mystical Body,



leading them to abandon Christ and His Way, leading them to apostasy. What are we to do? What is the Church to do?

Some, even among Bishops, would tell us that the Church has to change her doctrine, her Sacred Worship, and her discipline, in order to accommodate the culture. They talk about a necessary paradigm shift or an ill-defined synodal way which declares that all are welcome in the Church without making clear the conversion to Christ which is necessary to be a member of His Mystical Body....Our Lord wants all of us to share in the banquet of divine grace, but we cannot do so unless our hearts, one with the Immaculate Heart of Mary, rest in His Most Sacred Heart, unless we allow ourselves to be clothed with Him in our daily life.

The way of the Church in today's crisis is the same as it has always been. The teaching of the Deposit of Faith and of all the riches of the Catholic Faith, daily prayer and worship of God "in spirit and in truth," and a good and holy daily life. Before the great challenge of our time, Pope Saint John Paul II cautioned us that we will not save ourselves and our world by discovering "some magic formula" or by "inventing a new programme." In unmistakable terms, he declared:

"No, we shall not be saved by a formula but by a Person, and the assurance which he gives us: I am with you." He reminded us that the program by which we are to address effectively the great spiritual challenges of our time is, in the end, Jesus Christ alive for us in the Church.

... This is a program which does not change with shifts of times and cultures, even though it takes account of time and culture for the sake of true dialogue and effective communication.

In short, the program leading to freedom and happiness is, for each of us, holiness of life, in accord with our state in life and the particular gifts with which God has endowed us....
